MOBILE APP TERMS AND CONDITIONS OF USE

1. About the Application

- Welcome to Integrity Group Fitness Studios (the 'Application'). The Application group fitness classes (the 'Services ').
- (b) The Application is operated by Integrity Group Fitness Studios PTY. LTD. (ABN 53 160 008 186). Access to and use of the Application, or any of its associated Products or Services, is provided by Integrity Group Fitness Studios. Please read these terms and conditions (the '**Terms**') carefully. By using, browsing and/or reading the Application, this signifies that you have read, understood and agree to be bound by the Terms. If you do not agree with the Terms, you must cease usage of the Application, or any of its Services, immediately.
- (c) Integrity Group Fitness Studios reserves the right to review and change any of the Terms by updating this page at its sole discretion. When Integrity Group Fitness Studios updates the Terms, it will use reasonable endeavours to provide you with notice of updates to the Terms. Any changes to the Terms take immediate effect from the date of their publication. Before you continue, we recommend you keep a copy of the Terms for your records.

2. Acceptance of the Terms

You accept the Terms by using or browsing the Application. You may also accept the Terms by clicking to accept or agree to the Terms where this option is made available to you by Integrity Group Fitness Studios in the user interface.

3. Subscription to use the Services

- In order to access the Services, you must first purchase a subscription through the Application (the 'Subscription') and pay the applicable fee for the selected Subscription (the 'Subscription Fee').
- (b) In purchasing the Subscription, you acknowledge and agree that it is your responsibility to ensure that the Subscription you elect to purchase is suitable for your use.
- (c) Once you have purchased the Subscription, you will then be required to register for an account through the Application before you can access the Services (the 'Account').
- (d) As part of the registration process, or as part of your continued use of the Services, you may be required to provide personal information about yourself (such as identification or contact details), including:
 - (i) Email address

- (ii) Preferred username
- (iii) Mailing address
- (iv) Telephone number
- (v) Password
- (e) You warrant that any information you give to Integrity Group Fitness Studios in the course of completing the registration process will always be accurate, correct and up to date.

4. Your obligations as a Member

5. Payment

In using the Application, the Services or when making any payment in relation to your use of the Services, you warrant that you have read, understood and agree to be bound by the Stripe terms and conditions which are available on their Application.
- You acknowledge and agree that where a request for the payment of the Subscription Fee is returned or denied, for whatever reason, by your financial institution or is unpaid by you for any other reason, then you are liable for any costs, including banking fees and charges, associated with the Subscription Fee.
- You agree and acknowledge that Integrity Group Fitness Studios can vary the Subscription Fee at any time and that the varied Subscription Fee will come into effect following the conclusion of the existing Subscription Period.

6. Refund Policy

Integrity Group Fitness Studios will only provide you with a refund of the Subscription Fee in the event they are unable to continue to provide the Services or if the manager of Integrity Group Fitness Studios makes a decision, at its absolute discretion, that it is reasonable to do so under the circumstances . Integrity Group Fitness Studios does not grant you any other rights whatsoever in relation to the Application or the Services. All other rights are expressly reserved by Integrity Group Fitness Studios.

- (c) Integrity Group Fitness Studios retains all rights, title and interest in and to the Application and all related Services. Nothing you do on or in relation to the Application will transfer any:
 - (i) business name, trading name, domain name, trade mark, industrial design, patent, registered design or copyright, or
 - a right to use or exploit a business name, trading name, domain name, trade mark or industrial design, or
 - (iii) a thing, system or process that is the subject of a patent, registered design or copyright (or an adaptation or modification of such a thing, system or process),

to you.

You may not, without the prior written permission of Integrity Group Fitness
 Studios and the permission of any other relevant rights owners: broadcast,
 republish, upload to a third party, transmit, post, distribute, show or play in
 public, adapt or change in any way the Services or third party Services for any

purpose, unless otherwise provided by these Terms. This prohibition does not extend to materials on the Application, which are freely available for re-use or are in the public domain.

8. Privacy

Integrity Group Fitness Studios takes your privacy seriously and any information provided through your use of the Application and/or Services are subject to Integrity Group Fitness Studios's Privacy Policy, which is available at www.integritygroupfitness.com.au.

9. General Disclaimer

- Nothing in the Terms limits or excludes any guarantees, warranties, representations or conditions implied or imposed by law, including the Australian Consumer Law (or any liability under them) which by law may not be limited or excluded.
- (b) Subject to this clause, and to the extent permitted by law:
 - (i) all terms, guarantees, warranties, representations or conditions which are not expressly stated in the Terms are excluded; and
 - (ii) Integrity Group Fitness Studios will not be liable for any special, indirect or consequential loss or damage (unless such loss or damage is reasonably foreseeable resulting from our failure to meet an applicable Consumer Guarantee), loss of profit or opportunity, or damage to goodwill arising out of or in connection with the Services or these Terms (including as a result of not being able to use the Services or the late supply of the Services), whether at common law, under contract, tort (including negligence), in equity, pursuant to statute or otherwise.
- (c) Use of the Application and the Services is at your own risk. Everything on the Application and the Services is provided to you "as is" and "as available" without warranty or condition of any kind. None of the affiliates, directors, officers, employees, agents, contributors and licensors of Integrity Group Fitness Studios make any express or implied representation or warranty about the Services or any products or Services (including the products or Services of Integrity Group Fitness Studios) referred to on the Application. - (b) You expressly understand and agree that Integrity Group Fitness Studios, its affiliates, employees, agents, contributors and licensors shall not be liable to you for any direct, indirect, incidental, special consequential or exemplary damages which may be incurred by you, however caused and under any theory of liability. 12. Termination of Contract

- (a) The Terms will continue to apply until terminated by either you or by Integrity Group Fitness Studios as set out below.
- (b) If you want to terminate the Terms, you may do so by:
 - (i) not renewing the Subscription prior to the end of the Subscription Period;
 - providing Integrity Group Fitness Studios with 7 days' notice of your intention to terminate; and
 - (iii) closing your accounts for all of the services which you use, where
 Integrity Group Fitness Studios has made this option available to you.

Your notice should be sent, in writing, to Integrity Group Fitness Studios via the

'Contact Us' link on our homepage.

- (c) Integrity Group Fitness Studios may at any time, terminate the Terms with you if:
 - (i) you do not renew the Subscription at the end of the Subscription Period;
 - (ii) you have breached any provision of the Terms or intend to breach any provision;
 - (iii) Integrity Group Fitness Studios is required to do so by law;
 - (iv) the provision of the Services to you by Integrity Group Fitness Studios is, in the opinion of Integrity Group Fitness Studios, no longer commercially viable.
- (d) Subject to local applicable laws, Integrity Group Fitness Studios reserves the right to discontinue or cancel your membership at any time and may suspend or deny, in its sole discretion, your access to all or any portion of the Application or the Services without notice if you breach any provision of the Terms or any applicable law or if your conduct impacts Integrity Group Fitness Studios's name or reputation or violates the rights of those of another party.

13. Indemnity

- You agree to indemnify Integrity Group Fitness Studios, its affiliates, employees, agents, contributors, third party content providers and licensors from and against:
 - all actions, suits, claims, demands, liabilities, costs, expenses, loss and damage (including legal fees on a full indemnity basis) incurred, suffered or arising out of or in connection with Your Content;
 - (ii) any direct or indirect consequences of you accessing, using or transacting on the Application or attempts to do so; and/or
 - (iii) any breach of the Terms.

14. Dispute Resolution

(a) Compulsory:

If a dispute arises out of or relates to the Terms, either party may not commence any Tribunal or Court proceedings in relation to the dispute, unless the following clauses have been complied with (except where urgent interlocutory relief is sought).

(b) Notice:

A party to the Terms claiming a dispute ('**Dispute**') has arisen under the Terms, must give written notice to the other party detailing the nature of the dispute, the desired outcome and the action required to settle the Dispute.

(c) Resolution:

On receipt of that notice ('**Notice**') by that other party, the parties to the Terms ('**Parties** ') must:

- Within 7 days of the Notice endeavour in good faith to resolve the Dispute expeditiously by negotiation or such other means upon which they may mutually agree;
- (ii) If for any reason whatsoever, 14 days after the date of the Notice, the Dispute has not been resolved, the Parties must agree upon selection of a mediator.
- (iii) The Parties are equally liable for the fees and reasonable expenses of a mediator and the cost of the venue of the mediation and without limiting the foregoing undertake to pay any amounts requested by the mediator as a pre-condition to the mediation commencing. The Parties must each pay their own costs associated with the mediation;
- (iv) The mediation will be held in Ballarat, Australia.

(d) Confidential

All communications concerning negotiations made by the Parties arising out of and in connection with this dispute resolution clause are confidential and to the extent possible, must be treated as "without prejudice" negotiations for the purpose of applicable laws of evidence.

(e) Termination of Mediation:

If 14 have elapsed after the start of a mediation of the Dispute and the Dispute has not been resolved, either Party may ask the mediator to terminate the mediation and the mediator must do so.

15. Venue and Jurisdiction

The Services offered by Integrity Group Fitness Studios is intended to be viewed by residents of Australia. In the event of any dispute arising out of or in relation to the Application, you agree that the exclusive venue for resolving any dispute shall be in the courts of Victoria, Australia.

16. Governing Law

The Terms are governed by the laws of Victoria, Australia. Any dispute, controversy, proceeding or claim of whatever nature arising out of or in any way relating to the Terms and the rights created hereby shall be governed, interpreted and construed by, under and pursuant to the laws of Victoria, Australia, without reference to conflict of law principles, notwithstanding mandatory rules. The validity of this governing law clause is

not contested. The Terms shall be binding to the benefit of the parties hereto and their successors and assigns.

17. Independent Legal Advice

Both parties confirm and declare that the provisions of the Terms are fair and reasonable and both parties having taken the opportunity to obtain independent legal advice and declare the Terms are not against public policy on the grounds of inequality or bargaining power or general grounds of restraint of trade.

18. Severance

If any part of these Terms is found to be void or unenforceable by a Court of competent jurisdiction, that part shall be severed and the rest of the Terms shall remain in force.
